






#### Were you subjected to sexual violence as a child on more than one occasion?



# Did the sexual violence you were subjected to as a child happen online (completely or partially) or was it in some way facilitated by technology?

Technology facilitated sexual abuse, refers to all acts of sexual violence against a child which has to any extent been made possible through technological means. This can entail acts where some parts of the sexual violence have been facilitated by technology, or the sexual violence may have taken place completely through technological means, with no physical contact between the offender and the child. Some examples of technology facilitated sexual abuse include grooming and sexual advancements by adults toward a child through technological means (e.g., text messages, online messaging, social media, gaming platforms), an adult sending nude or sexually explicit content of themselves to a child, requesting/showing/producing/sharing images/videos of the sexual violence (nude or sexually explicit content depicting the child). The acts can also take place in real time through live-streaming.



# Did the sexual violence you were subjected to as a child relate to trafficking/commercial sexual exploitation\*?

Trafficking/commercial sexual exploitation refers to acts of sexual violence against a child which aims to create monetary/financial gain. These acts can also be conducted virtually. Examples of trafficking/commercial sexual exploitation may include offering a child money in exchange for sexual acts, the production and distribution of images/videos depicting a child nude or in a sexually explicit manner, also in real time through live-stream.



#### What gender were the perpetrator(s)?

















# Which of the following options best describes the barriers for your disclosure immediately following the sexual violence?




#### Did your disclosure lead to you receiving support/help?
















